Minimaalsed nõuded süsteemile

- Võrgukaardiga arvuti.
- Cat.5 või Cat.6 võrgukaabel.
- Pistikupesa peab olema kuni 1,82 m kaugusel switchist.
- Kontrollige visuaalselt alalisvoolu toitepistikut, et see on turvaliselt toiteplokkiga ühendatud.
- Veenduge, et switchi ümber on sobiv soojuste hajutamine ja piisav ventilatsioon.

2. Riistvara paigaldus

1. Ühendage AC toiteplokk TEG- S50g / TEG-S80g'iga ning seejärel pistikupessa.



2. Ühendage Cat.5e või Cat.5 RJ-45 network võrgukaabel arvutist TE100-S5/TE100-S8'i vabasse Etherneti porti.
