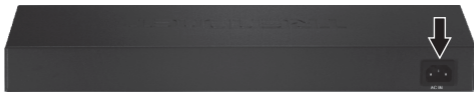

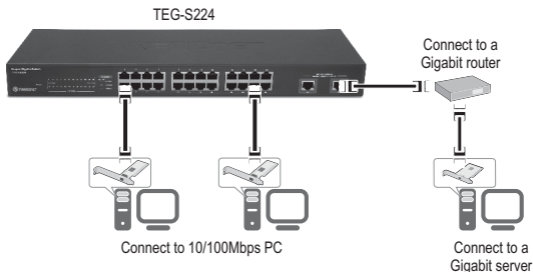

2. Ühendage CAT-5e või CAT-6 RJ-45 network võrgukaabel arvutist TEG-S224'i vabasse Etherneti porti.



Seadmekapp

Switch saab paigaldada EIA standard-size, 19-tollise rack, mis võib paigutada juhtmeid kapp koos teiste seadmetega.
