1. Подготовка к монтажу

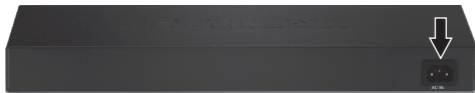

Минимальные требования

- Компьютер с соответствующим образом установленным сетевым адаптером
- Достаточно прохладное и сухое место
- Место, в котором отсутствуют источники электромагнитных полей (напр., двигатели), вибрация, пыль, и куда не проникает прямой солнечный свет
- Для обеспечения необходимой вентиляции оставьте минимум 10 см спереди и сзади коммутатора
- дюймовая стойка стандарта или прочная, ровная поверхность, способная выдержать вес коммутатора

2. Установка оборудования

1. Присоедините сетевой провод к тыльной стороне устройства TEG-S224 и затем к сетевой розетке.



2. Подключите сетевой кабель RJ-45 от компьютера к порту Ethernet на устройстве TEG-S224.



Коммутатор может быть установлен в 19-дюймовой стойке стандартного размера, которая располагается в электромонтажном шкафу вместе с другой аппаратурой.

3. Приложите крепежные скобы к обеим сторонам коммутатора и прикрепите их имеющимися винтами.



4. Аккуратно расположите коммутатор на стойке. Выровняйте кронштейн относительно винтовых отверстий на стойке, затем прикрепите коммутатор винтами из комплекта к приборной стойке.
