

2. Procéder à l'installation

<u>Remarque:</u> Veuillez consulter la partie du mode d'emploi de votre ordinateur traitant de l'installation de matériel

Windows 2000/XP

- 1. Eteignez votre ordinateur.
- 2. Ouvrez le boîtier de votre ordinateur.
- Insérez fermement la Carte PC dans un logement PCI libre de votre PC de bureau et ensuite reboot (redémarrez) ce dernier.



4. Après le redémarragage de votre PC, Windows installera automatiquement votre nouveau matériel.



5. Branchez les périphériques FireWire IEEE 1394 aux ports FireWire.

Troubleshooting

Q1: Where is the Driver CD-Rom for the TFW-H3PI?

A1: The TFW-H3PI does not require unique drivers for Windows XP/2000/ME; it uses preinstalled FireWire drivers provided by your operating system. Your computer must have FireWire ports that are properly installed.

Q2: Can I connect or disconnect the FireWire cable while the computer is on?
A2: Yes, you can connect or disconnect the FireWire cable, or any external FireWire device while the computer is on because the FireWire interface is Plugand-Play and hot-pluggable.

Q3: After successfully installing the TFW-H3PI FireWire PCI Adapter, I connected my external FireWire device to the FireWire port, but it doesn't seem to work. What should I do?

A3: Make sure you connect your external AC Power Adapter to the external FireWire device and that the device is powered on. Also make sure that you have installed the correct driver for you external FireWire device.
