Системные требования

- Компьютер с портом USB 2.0 или 1.1 типа A
- Внутренний жесткий диск SATA I/II, IDE
- Дисковод CD-ROM
- ЦП: 300 МГц или выше
- Память: 256МБ или более
- Windows XP, 2000, ME, 98SE
 Примечание: жесткий диск НЕ входит в комплект.

2. Установка оборудования



<u>Примечание:</u> читайте указания в разделе Устранение неисправностей касательно установки устройства TSE-IS401 в системе Windows 98SE.

1. Отверните 4 винта с днища для отсоединения крышки.




2. Для снятия металлической крышки жесткого диска снимите 4 винта.



Перемычка на жестком диске должна быть в положении Master.


5. Установите поверх жесткого диска металлическую крышку и закрепите ее 4-мя винтами.




6. Задвиньте крышку на место и закрепите ее 4-мя винтами.



- 7. Присоедините сетевой шнур к адаптеру питания переменного тока.
- **8.** Подключите внешний адаптер питания к файловому серверу и затем к сетевой розетке.

3. Доступ к запоминающим устройствам на TSE-IS401

3. Двойным щелчком выберите значок **Мой компьютер**. Затем двойным щелчком выберите любой установленный жесткий диск в разделе **Network Drives**.

Troubleshooting

Q1: My computer does not recognize the TSE-IS401. What should I do?

A1: First, verify that the computer meets the minimum requirements as listed in section 1. Second, make sure that you have plugged in the power into the unit and the power cord into an outlet. Third, try plugging the device into a different USB port on your computer.

Q2: How do I format my brand new hard drive?

A2: For Windows 2000/XP, go to Start -> Settings -> Control Panel -> Administrative Tools -> Computer Management -> Disk Management. If the Initialize and Convert Disk Wizard appears, click Cancel. Right click the Unknown drive, click Initialize and then click OK. Right click on the unallocated region of the hard drive and select New Partition. Follow the New Partition Wizard instructions then click Finish. The hard drive will automatically start the formatting process.

For Windows 98SE/ME, right click on **My Computer**, and then click **Device Manager**. Double-click on **Disk drives**, and then double-click on your hard drive. When the hard drive properties window appears, click on the **Settings** Tab. Check **Removable** in the **options** section, select an available drive letter for **Start drive letter** and then click **OK**. Click **Close**. Click **Yes** to restart the computer. Double click on **My Computer**, double-click on the hard drive and click **Yes** to format it.

Q3: How do I install the TSE-IS401 on Windows 98SE?

- A3: 1) Insert the Driver CD-ROM into the CD-ROM drive
 - Go to start -> run -> type in D:\Driver\Win98\Setup.exe and click OK. D represents the drive letter of your CD-ROM drive.
 - 3) Setup successful will appear. Click OK.
 - 4) Follows steps 1-10 in Section 2 to complete the installation.

Q4: My computer does not recognize my hard drive(s)? What should I do?

A4: First, verify that the device is installed properly. Right click on My Computer Properties. Click on **Hardware** and then **Device Manager**. Double click on **Disk Drives**. Make sure that your hard drive is listed and there is no yellow question mark or exclamation point. Second, if you are attaching a brand new hard drive, format the drive. Please refer to question 2 for more information. Third, the hard drive that is connected to the TSE-IS401 must be formatted in FAT-16 or FAT-32 in order for Windows 98SE or ME to recognize it

Limited Warranty
