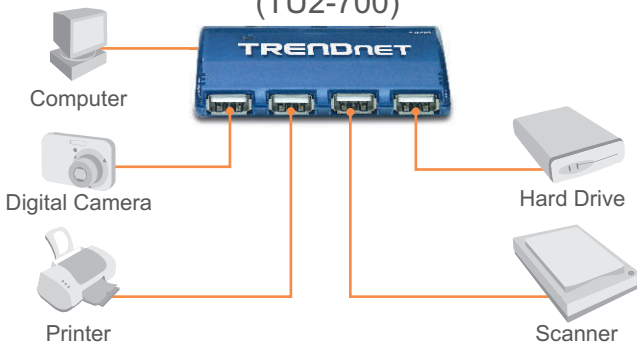

2. Installation du matériel

Remarque: Pour profiter du haut débit USB, tous vos périphériques USB doivent être USB 2.0 à haut débit.

1. Allumez votre ordinateur et attendez qu'il soit totalement démarré.



2. Branchez le câble USB fourni au Hub USB et au port USB de votre ordinateur.



3. Branchez l'adaptateur secteur AC au Hub USB.



4. Branchez le matériel USB à un port USB disponible.

L'installation est maintenant complète.

Q1: Can I connect or disconnect the USB cable while the computer is on?

A1: Yes, you can connect or disconnect the USB cable, or any external USB device while the computer is on because the USB interface is Plug-and-Play and hot-pluggable.

Q2: I have a USB 1.1 cable. Can it work with USB 2.0 devices?

A2: Yes, it works but it may cause problems when connecting high-speed USB 2.0 external peripherals. Therefore it is recommended that you use a certified USB 2.0 cable.

Q3: After successfully installing the TU2-700 USB 2.0 Hub, I connected my external USB device to the USB port, but it doesn't seem to work. What should I do?

A3: If you have an external AC power adapter that came with the external USB device, connect the AC power adapter to the device and power on the device. Also make sure that you have installed the correct driver for your external USB device.
