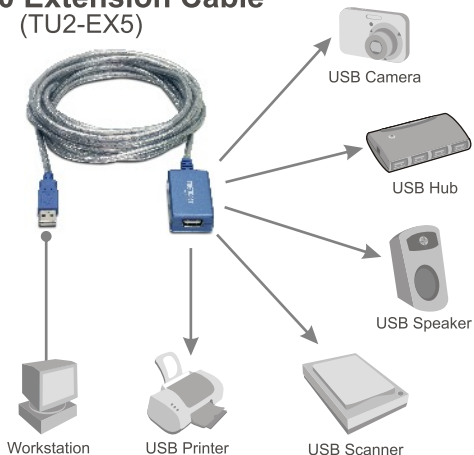

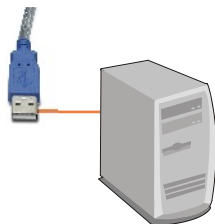
## Применение

### USB 2.0 Extension Cable (TU2-EX5)



## 2. Установка оборудования

1. Вставьте штыревой разъем USB Type A устройства TU2-EX5 в USB-порт компьютера.



2. Компьютер автоматически определит и установит нужные драйверы.

3. Присоедините периферийное устройство USB к гнездовому разъему USB Type A устройства TU2-EX5.

**Q1: My computer does not detect my USB peripheral device when I plug it into the TU2-EX5. What should I do?**

**A1:** First, verify the USB device on the host computer are installed properly. Right click on **My Computer -> Properties**. Click on **Hardware**, then **Device Manager**. Double click on **Universal Serial Bus Controllers**. Make sure that **Generic USB Hub** is listed and there is no yellow question mark or exclamation point. Second, try plugging the device into a different USB port on the computer.

**Q2: My USB peripheral is getting less than 480Mbps data transfer rate when connected through the TU2-EX5. What should I do?**

**A2:** First, verify that the TU2-EX5 is connected to a USB 2.0 port on your computer. Second, make sure that your USB peripheral device supports USB 2.0.

**Q3: Can I cascade 2 or more TU2-EX5 together?**

**A3:** You can cascade a total of five TU2-EX5 units together.

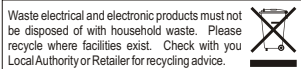
