2. Порядок установки

Это важно! Не получив необходимого указания, НЕ устанавливайте в компьютере PC-карту.

Пользователям Windows

B среде Windows 98SE начните с шага 1. В ОС Windows Me/XP/2003 Server и Vista пропустите шаг 3.

1. Установите в дисковод CD-ROM компакт-диск с драйверами. При автоматическом появлении окна нажмите на Установить драйвер.



2. Выберите **Нет**, **я перезагружу компьютер позже** и нажмите на кнопку **Закрыть**.



3. Отключите компьютер.



4. Плотно задвиньте РС-карту в свободный слот для РС-карт в портативном компьютере (notebook) и затем выполните перезагрузку.



5. После перезагрузки Windows автоматически выполнит установку нового оборудования.



6. Присоедините устройства USB к портам USB.

Troubleshooting

Q1: Can I connect or disconnect the USB cable while the computer is on?

A1: Yes, you can connect or disconnect the USB cable, or any external USB device while the computer is on because the USB interface is Plug-and-Play and hot-pluggable.

Q2: I have a USB 1.1 cable. Can it work with USB 2.0 devices?

A2: Yes, it works but it may cause problems when connecting high-speed USB 2.0 external peripherals. Therefore it is recommended that you use a certified USB 2.0 cable.

Q3: After successfully installing the TU2-H4PC USB 2.0 PC Card, I connected my external USB device to the USB port, but it doesn't seem to work. What should I do?

A3: If you have an external AC power adapter that came with the external USB device, connect the AC power adapter to the device and power on the device. Also make sure that you have installed the correct driver for your external USB device.
