

2. Порядок установки

Это важно! Не получив необходимого указания, НЕ устанавливайте в компьютере PCI-адаптер.

Пользователям Windows


1. Установите в дисковод CD-ROM компакт-диск с драйверами. При автоматическом появлении окна нажмите на **Установить драйвер**.



2. Появится предупреждение. Выберите **Все равно продолжить**. (только Windows XP).



3. При сообщении о необходимости перезагрузки, выберите **Нет** и нажмите на кнопку **Закреть**.



Примечание: касательно установки оборудования обратитесь к руководству пользователя своего компьютера.

4. Отключите компьютер.

5. Откройте корпус компьютера.




6. Плотно задвиньте PCI-карту в свободный слот для PCI-карт настольного ПК и затем **выполните перезагрузку.**



7. После перезагрузки Windows автоматически выполнит установку нового оборудования.

8. Присоедините устройства USB к портам USB.

Q1: Can I connect or disconnect the USB cable while the computer is on?

A1: Yes, you can connect or disconnect the USB cable, or any external USB device while the computer is on because the USB interface is Plug-and-Play and hot-pluggable.

Q2: I have a USB 1.1 cable. Can it work with USB 2.0 devices?

A2: Yes, it works but it may cause problems when connecting high-speed USB 2.0 external peripherals. Therefore it is recommended that you use a certified USB 2.0 cable.

Q3: After successfully installing the TU2-H5PI USB 2.0 PCI Adapter, I connected my external USB device to the USB port, but it doesn't seem to work. What should I do?

A3: If you have an external AC power adapter that came with the external USB device, connect the AC power adapter to the device and power on the device. Also make sure that you have installed the correct driver for your external USB device.

Q4: How do I install the TU2-H5PI on my Windows 98SE computer?

A4: Follow the instructions below:

1. Follow steps 1-7 in **Section 2 How to Install**.
2. When the computer boots up, the Found New Hardware wizard appears. Click **Next**.
3. When the Insert Disk window appears, insert your Windows 98SE CD into your CD-ROM drive and then click **OK**.
4. Click **Finish**.
5. Repeat steps 1-4.
6. Connect USB devices to the USB ports.
