TRENDnet's USB 3.0 to Gigabit Adapter + USB Hub, model TU3-ETGH3, adds a Gigabit Ethernet port and three 5 Gbps SuperSpeed USB 3.0 ports to a Windows® or Mac® computer. The TU3- ETGH3 is also compatible with USB 2.0 and 1.1 ports. An included optional power adapter provides full power to power hungry USB devices.




Windows 8.1/8/7/ Vista/XP Driver Installation

Caution: DO NOT connect the Ethernet adapter to your computer before you install the provided driver. You will be instructed to do so later.


1. Insert the included CD, click on Install Driver option

3. Click **Finish** to complete the driver installation




Now the installation is completed. You can connect the adapter to your USB 2.0/3.0 port then connect your network cable from the router to the adapter.

The Link LED should light up green to indicate a proper physical connection between the adapter and the network. If the Link LED doesn't light up, please verify the cable connections between all the network devices.



Mac OS 10.6/10.7/10.8/10.9 Driver Installation


1. Insert the provided driver CD into your CD-ROM drive, browse to the MAC folder. Double-click **<AX88179....pkg>** to launch the setup procedure




2. When the **Install AX88179/178A Adapter Driver** screen appears, please select **Continue**.



3. When the screen below appears, please click **Install** to install




4. When the screen below appears, please click Continue Installation




5. Please enter your password as prompted.

Verifying the Driver Installations

For Windows

Once you finished the installation, you can open Windows **Device Manager** to verify if your Ethernet adapter is properly installed.

To access the **Device Manager:**

- On Windows® 7 / Windows® 8 / Windows 8.1 ®: Right-click Computer on the desktop and click System Properties>Device Manager
- On Windows[®] Vista: Right-click Computer on the desktop and click
 Properties > Device Manager.
- On Windows[®] XP: Right-click My **Computer** on the desktop and click **Properties** > (Hardware) > **Device Manager**.

In the Network adapters group, an item named **ASIX AX88179 USB 3.0 to Gigabit Ethernet Adapter** should be displayed.

If there is a question or exclamation mark next to that item, then the driver is not properly installed. Please delete the item, select the **Delete the driver software for this device** option (if provided), unplug the adapter from your computer and then repeat the installation steps.


