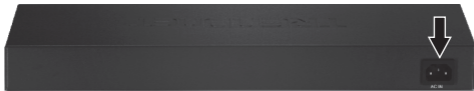

Requisitos Mínimos

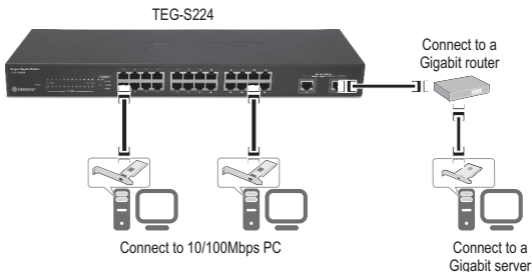
- Computador com adaptador de rede instalado
- Um ambiente que é bastante fresco e seco
- Um ambiente que está livre de geradores eletromagnéticos fortes de campo (tais como motores), poeira, vibração e exposição direta à luz solar
- Deixe pelo menos 10 cm de espaço na frente e traseira do Switch para ventilação
- EIA Standard, rack de 19 polegadas ou superfície firme e nivelada, que pode suportar o peso do Switch

2. Instalação de Hardware

1. Conecte o Cabo de Alimentação ao TEG-S224 e então a uma tomada elétrica.



2. Conecte um cabo de rede RJ-45 CAT-5e ou CAT-6 do computador a uma porta Ethernet disponível no TEG-S224



O Switch pode ser montado em um tamanho padrão EIA, rack de 19 polegadas, que pode ser colocado em um armário de fiação com outros equipamentos.

3. Prenda os suportes de montagem para ambos os lados do interruptor e prenda-os com os parafusos fornecidos.



4. Atentamente a posição do interruptor no rack. Alinhe o suporte para os orifícios dos parafusos no rack, então use os parafusos fornecidos com o rack de equipamentos para montar o switch.
