## 1. Before You Start

## **Package Contents**

- TEG-S5q
- Multi-Language Quick Installation Guide
- · Power Adapter (5V DC, 1A)

If any of the above contents are missing, please contact your reseller.

### Minimum Requirements

- · Computer with network adapter installed
- . Cat.5e or Cat.6 network cable
- . The surface must support at least 125g for the Switch
- . The power outlet should be within 1.82 meters (6 feet) of the switch
- Visually inspect the DC power jack to make sure that it is securely connected to the power adapter
- Make sure that there is proper heat dissipation from and adequate ventilation around the Switch
- · Do not place heavy objects on the switch

### 2. How to Install

1. Connect the Power Adapter to the TEG-S5g and then to a power outlet.



Connect a Cat.5e or Cat.6 RJ-45 network cable from the computer to an available Ethernet port on the TEG-S5g.



## 3. LEDs



#### Power

Green: Power is on

Not Illuminated: Power is off

### Link/ACT

Green (Solid): Link to another device

Green (Blinking): Activity is occurring from the link
Not Illuminated: Nothing is detected on the port

### Speed

Green: Connection for the port is 2000Mbps (Full)

Not Illuminated: Connection for the port is 100/200Mbps (Half/Full),

10/20Mbps (Half/Full) or nothing is detected on the port.

## Troubleshooting

#### 1. After connecting the Switch to a power outlet, the LEDs do not turn on.

- Check the connection of the power adapter to the TEG-S5g and the power outlet.
- 2. Check that the power outlet is receiving power.

# 2. When I connect a computer to one of the ports on the Switch, the Link/ACT LED turns on, but I am not getting Gigabit speeds.

- Check the LEDs. If the Speed LED is green, the computer's connection speed is 1000Mbps. If the Speed LED is off, the computer's connection speed is 100Mbps or 10Mbps.
- Check the Ethernet Cable. Make sure you are using CAT.5e or CAT.6 Ethernet cables. Some CAT-5 cables are not rated to run in Gigabit.
- Make sure that you have a Gigabit Ethernet Adapter installed on your computer.

#### 3. After I connect my PCs to the Switch, I am unable to share files.

- 1. Check the LEDs on the Switch. Make sure the Link/ACT LED is on.
- Check the network cable. The minimum length of the cable is 1.5 meters and the maximum length of the cable is 100 meters.
- 3. Disable any software firewall program.
- Verify that you have file sharing enabled. Please contact your Operating System support for more information.

### After I connect my PCs to the Switch, I can only get onto the Internet from one computer.

The Switch was not designed to share Internet between multiple computers. You need to get an Internet router such as the TW100-S4W1CA.

#### 5. Where is the uplink port located on the Switch?

Since all the ports on the Switch are Auto-MDIX, any of the ports can be used as an uplink port.
