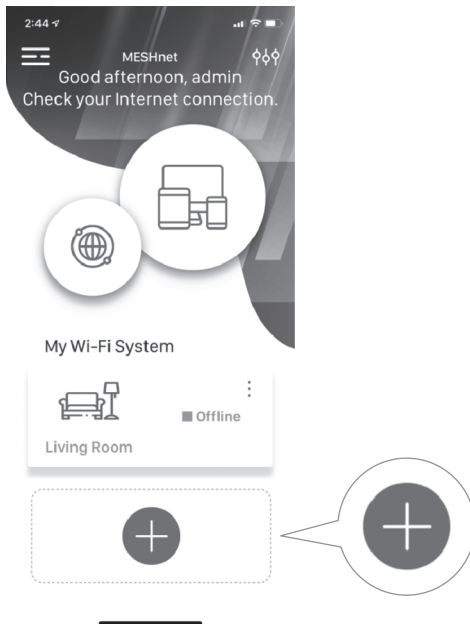

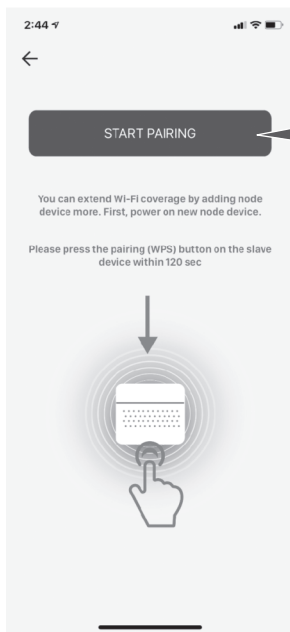
## 2. Instalação do hardware

### Opção 1: Configuração do MESHnet APP

1. Assim que todas as unidades estiverem ligadas, abra o APP para o kit de 2 pack existente que já foi configurado antes e clique no botão “+” na parte inferior da tela inicial.



2. Clique em Iniciar **START PAIRING** (Emparelhamento).

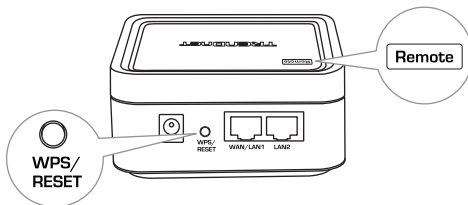

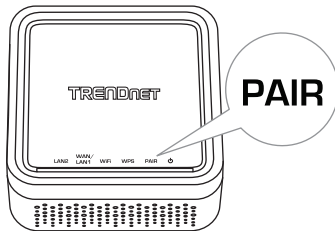
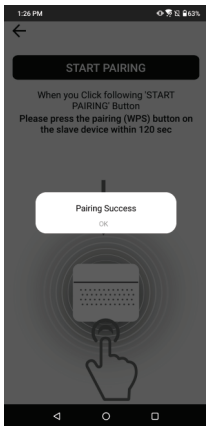

3. Vá para o novo nó **Remoto** e pressione e segure o botão **WPS/RESET** por 3 segundos e depois solte.

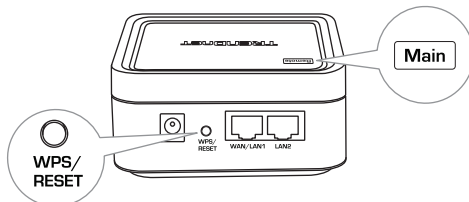

## Opção 2: Configuração WPS

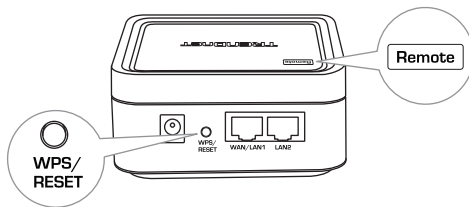
1. Vá para o nó **Principal** da rede existente e pressione e segure o botão **WPS/RESET** por 3 segundos na unidade e depois solte para iniciar a pesquisa.

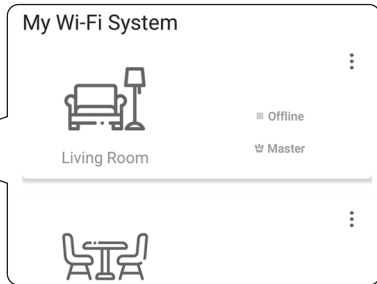
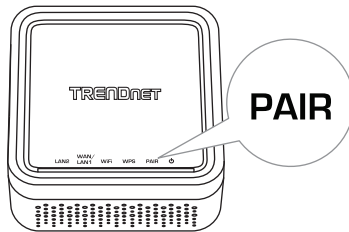
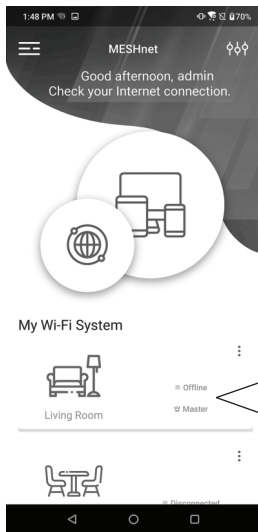


2. Vá para o novo nó **Remoto** e pressione e segure o botão **WPS/RESET** por 3 segundos e depois solte.

### Wall-mounted instructions

The Unit has two wall-mount slots on its bottom panel.

Before you begin, make sure you have two screws that indicate a diameter measurement of 0.1377 inches (4.0mm).

- (1) Determine where you want to mount the unit.
- (2) Drill two holes into the wall. Make sure adjacent holes are 4.51 inches (114 mm) apart.
- (3) Maneuver the unit so the wall-mount slots line up with the two screws.
- (4) Place the wall-mount slots over the screws and slide the unit down until the screws fit snugly into the wall-mount slots.
- (5) Screw type T3 x 15mm x 2

The equipment power supply cord shall be connected to a socket-outlet with earthing connection.

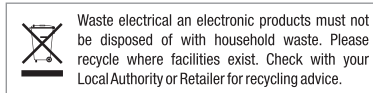
