


2. Instalación del hardware

Opción 1: Configuración de la MESHnet aplicación

- Una vez que todas las unidades estén encendidas, abra la aplicación, vaya al juego de 2 paquetes existente ya configurado y pulse el botón “+” en la parte inferior de la pantalla de inicio.



2. Haga clic en **START PAIRING** (Inicio del emparejamiento).





3. Vaya al **nodo remoto** de la nueva unidad individual; pulse y mantenga pulsado el botón **WPS/RESET** durante 3 segundos y luego suéltelo.



Opción 2: configuración de la WPS


- Vaya al nodo **principal** de la red existente y, a continuación, pulse y mantenga pulsado el botón **WPS/RESET** durante 3 segundos en la unidad y luego suéltelo para iniciar la búsqueda.

Nota: El LED **WPS/RESET** parpadeará en la unidad después de mantener pulsado el botón durante 3 segundos. Si se pulsa **[5 segundos]** o más, la unidad se colocará en **[restablecer a valores predeterminados]**.




- Vaya al nodo **remoto** de la nueva unidad individual; pulse y mantenga pulsado el botón **WPS/RESET** durante 3 segundos y luego suéltelo.

Wall-mounted instructions

The Unit has two wall-mount slots on its bottom panel.

Before you begin, make sure you have two screws that indicate a diameter measurement of 0.1377 inches (4.0mm).

- (1) Determine where you want to mount the unit.
- (2) Drill two holes into the wall. Make sure adjacent holes are 4.51 inches (114 mm) apart.
- (3) Maneuver the unit so the wall-mount slots line up with the two screws.
- (4) Place the wall-mount slots over the screws and slide the unit down until the screws fit snugly into the wall-mount slots.
- (5) Screw type T3 x 15mm x 2

The equipment power supply cord shall be connected to a socket-outlet with earthing connection.
