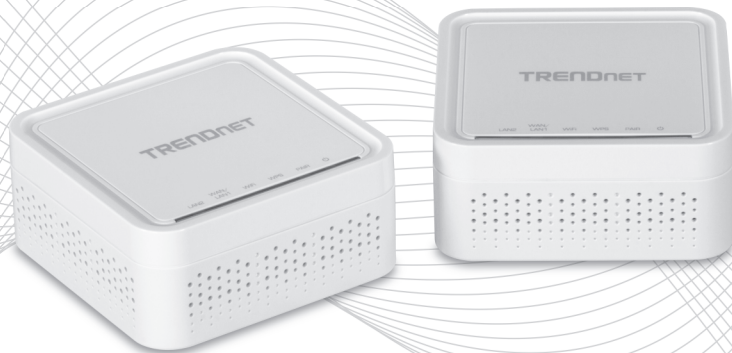

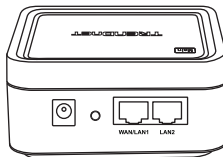

2. Instalação do hardware

1. Conecte o cabo de rede incluído da porta WAN do dispositivo identificado como “**Principal**” ao seu modem e ligue o dispositivo usando o adaptador de energia incluído.

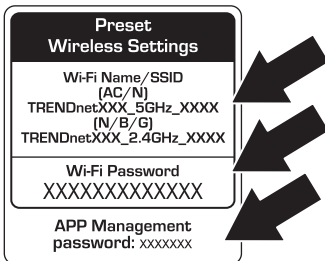


2. Usando seu dispositivo móvel, baixe e instale o aplicativo móvel TRENDnet “**MESHnet+**” escaneando o código QR abaixo com o seu dispositivo móvel.



3. Após a conclusão da instalação do aplicativo, conecte seu dispositivo móvel à rede sem fio do roteador.

Nota: Você encontrará o SSID e a senha do roteador na etiqueta na parte inferior da unidade ou na etiqueta das configurações sem **fin** predefinidas do dispositivo.



4. Abra o aplicativo TRENDnet MESHnet+.



5. Clique no botão **“Create Account”** (Criar conta) e siga os passos do APP.



6. Siga as etapas no aplicativo para configurar sua rede.

Nota: Certifique-se de que todos os nós estejam ligados e que os LEDs **“Piar”** estejam acesos, antes de aplicar qualquer alteração ao SSID ou senha sem fio. O nó **remoto** do kit é pré-programado para se emparelhar automaticamente com o SSID e a senha padrão do nó **principal**. Assim que o emparelhamento inicial for concluído, quaisquer alterações serão aplicadas a todos os nós emparelhados.

7. Para emparelhar nós remotos adicionais, consulte o Guia de instalação rápida do nó remoto.

A configuração da rede mesh WiFi está concluída.

Wall-mounted instructions

The Unit has two wall-mount slots on its bottom panel.

Before you begin, make sure you have two screws that indicate a diameter measurement of 0.1377 inches (4.0mm).

- (1) Determine where you want to mount the unit.
- (2) Drill two holes into the wall. Make sure adjacent holes are 4.51 inches (114 mm) apart.
- (3) Maneuver the unit so the wall-mount slots line up with the two screws.
- (4) Place the wall-mount slots over the screws and slide the unit down until the screws fit snugly into the wall-mount slots.
- (5) Screw type T3 x 15mm x 2

The equipment power supply cord shall be connected to a socket-outlet with earthing connection.

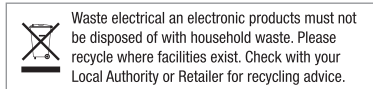
