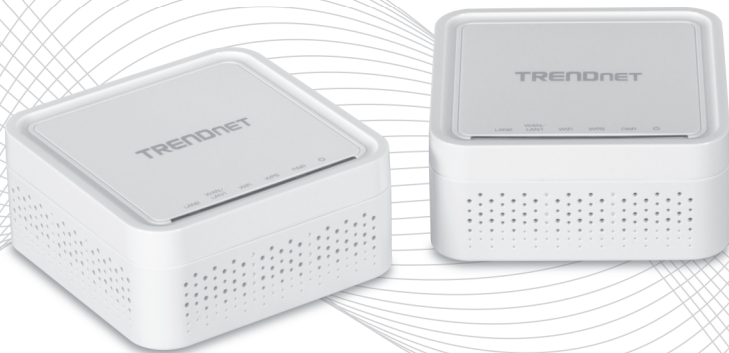

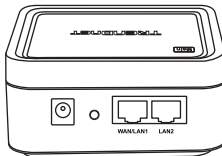

2. Instalación del hardware

1. Conecte el cable de red incluido desde el puerto WAN del dispositivo rotulado como **"Principal"** a su módem y encienda el dispositivo mediante el adaptador de alimentación incluido.

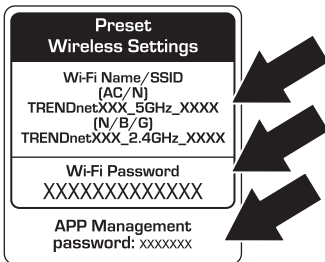


2. Utilizando su dispositivo móvil, descargue e instale la aplicación móvil **"MESHnet+"** de TRENDnet escaneando el código QR que corresponda a su dispositivo móvil más abajo.



3. Después de que la instalación de la aplicación haya finalizado, conecte su dispositivo móvil a la red inalámbrica del router.

Nota: Encontrará el SSID y la contraseña de su router en la etiqueta en la parte inferior de la unidad o en la etiqueta **de configuración wireless preseleccionada** del dispositivo.



4. Abra la aplicación MESHnet+ de TRENDnet.



5. Haga clic en el botón **“Create Account”** (Crear cuenta) y siga los pasos que indica la aplicación.



6. Siga los pasos que indica la aplicación para configurar su red.

Nota: Asegúrese de que todos los nodos estén encendidos y de que los LED de **“emparejamiento”** también estén encendidos, antes de aplicar cualquier cambio en la SSID wireless o la contraseña. El kit del nodo **remoto** está preprogramado para autoemparejarse al SSID predeterminado y a la contraseña del nodo **principal**; una vez que el emparejamiento inicial haya finalizado, los cambios se aplicarán a todos los nodos emparejados.

7. Para emparejar otros nodos **remotos**, consulte la Guía de instalación rápida del nodo remoto.

La configuración de su red WiFi de malla está terminada.

Wall-mounted instructions

The Unit has two wall-mount slots on its bottom panel.

Before you begin, make sure you have two screws that indicate a diameter measurement of 0.1377 inches (4.0mm).

- (1) Determine where you want to mount the unit.
- (2) Drill two holes into the wall. Make sure adjacent holes are 4.51 inches (114 mm) apart.
- (3) Maneuver the unit so the wall-mount slots line up with the two screws.
- (4) Place the wall-mount slots over the screws and slide the unit down until the screws fit snugly into the wall-mount slots.
- (5) Screw type T3 x 15mm x 2

The equipment power supply cord shall be connected to a socket-outlet with earthing connection.

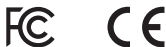

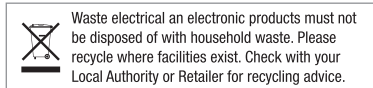
