# 2. Instalación del Hardware

**1.** Encienda su PC y espere hasta que le aparezca el escritorio de Windows.

# 3. Instalación del controlador

<u>Nota</u>: Después de introducir el TMR-61U2 en una de sus ranuras USB, Windows (XP/2000) detectará el dispositivo de forma automática. Pase a la sección apropiada detallada a continuación antes de instalar el controlador.

## Windows 2000/XP

**1.** Tras reiniciar su PC, Windows completará automáticamente la instalación de su nuevo hardware.


# 4. Verificar la instalación

## Windows 2000/XP

Haga clic derecho en My
 Computer (Mi PC) y luego haga
 clic en Properties (Propiedades).
 En de la pestaña Hardware, haga
 clic en el Device Manager (Gestor
 de dispositivo).



 Compruebe que el Generic volume (Volumen Genérico) y el USB Mass Storage Device (Dispositivo de almacenamiento masivo USB) estén instalados y que no aparecen signos de exclamación visibles.



**3.** Vaya a **My Computer** (Mi PC) y compruebe que aparecen cuatros discos portátiles.

# **Troubleshooting**

## Q1: Can I connect or disconnect the USB cables while the computer is on?

A1: Yes, you can connect or disconnect the USB cable, or any external USB device while the computer is on, because the USB interfaces are Plug-and-Play and hot-pluggable.

### Q2: I have a USB 1.1 cable. Can it work with USB 2.0 devices?

A2: Yes, it works but it may cause problems for connecting high-speed USB 2.0 external peripherals. Therefore it is recommended that you use a certified USB 2.0 cable.

## Q3: After successful installation of the TMR-61U2 USB 2.0 6-in-1 Memory Card Reader/Writer, I inserted my memory card into the slot and it is not working? What should I do?

A3: Make sure the memory card is properly inserted in the right slot and make sure the light comes on.
