



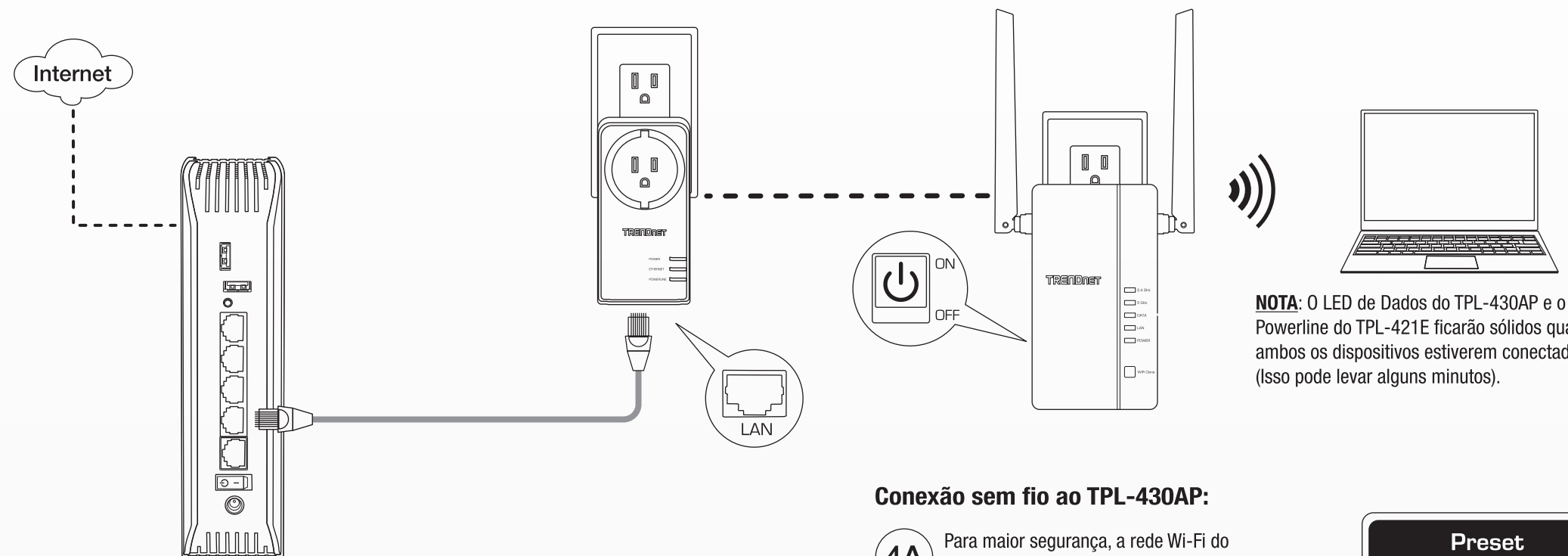

- 1 Conecte um cabo de rede do seu roteador à porta de rede do TPL-421E.
- 2 Conecte o TPL-421E (incluído no TPL-430APK) ou outro adaptador Homeplug AV.
- 3 Conecte o TPL-430AP à tomada e ligue-o.



NOTA: O LED de Dados do TPL-430AP e o LED Powerline do TPL-421E ficarão sólidos quando ambos os dispositivos estiverem conectados. (Isso pode levar alguns minutos).

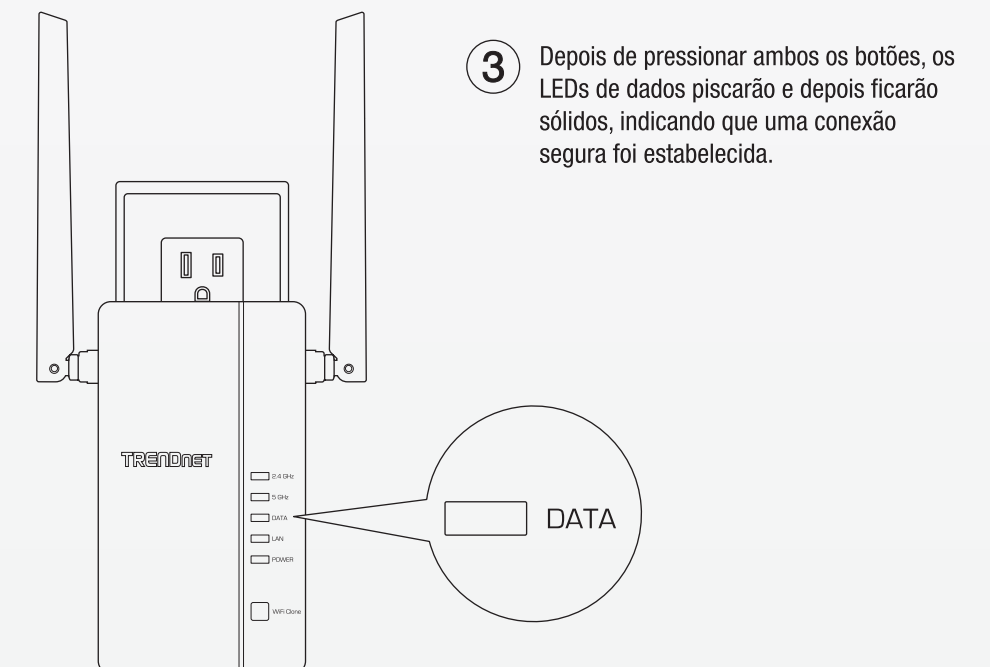
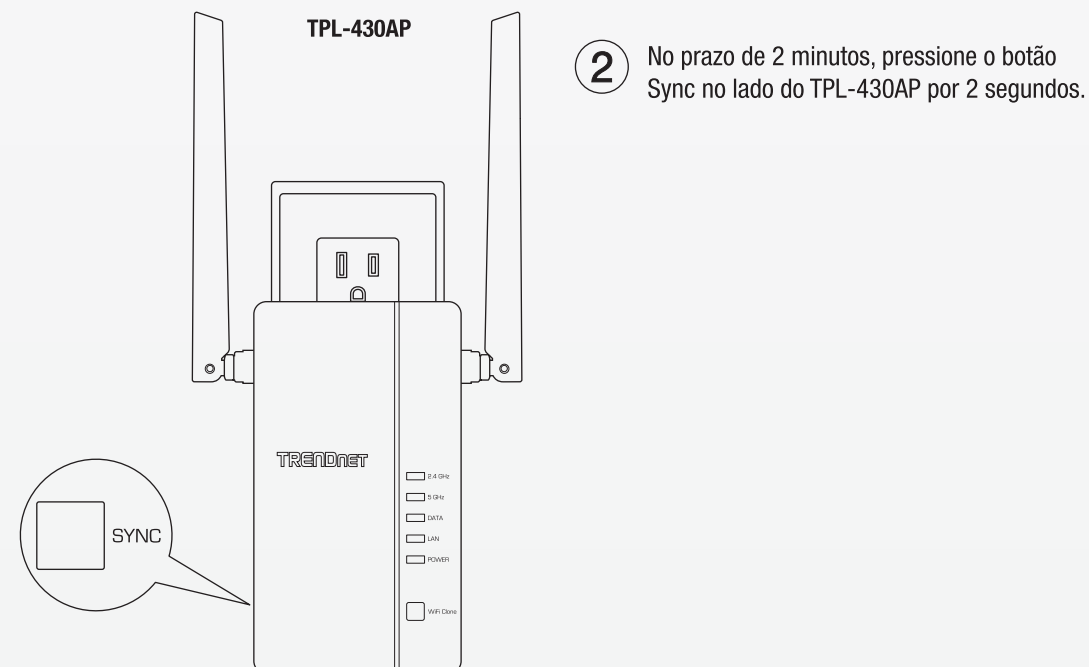
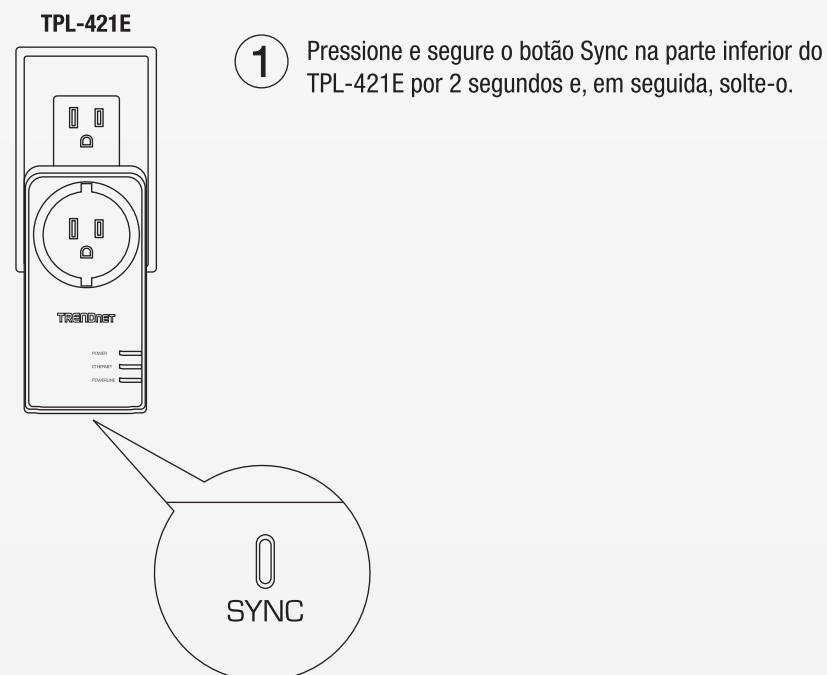
Conexão sem fio ao TPL-430AP:

- 4A Para maior segurança, a rede Wi-Fi do TPL-430AP é pré-criptografada com chave Wi-Fi exclusiva. Você pode encontrar a chave Wi-Fi exclusiva e o nome de rede pré-atribuída (SSID) na etiqueta do dispositivo localizada na parte traseira da unidade e no adesivo dentro da embalagem.
- 4B Para copiar as configurações de rede para o TPL-430AP, pressione o botão WPS no roteador e, em seguida, pressione e mantenha pressionado o botão clone Wi-Fi no TPL-430AP por 10 segundos.
