3. Вставьте в устройство для презентаций батареи.

Troubleshooting

Q1: Windows is unable to recognize the USB receiver. What should I do?

A1: First, make sure your computer meets the minimum requirements as specified in Section 1 of this guick installation guide. Second, connect the USB receiver to a different USB port on the computer.

Q2: I am unable to control Windows Media Player or PowerPoint. What should I do?

A2: You are in the incorrect mode. Press on Switch Mode key until the LED lights green.

Q3: All functions on the device stopped working. What should I do?

A3: First, you must be within 15 meters of the computer. Second, the device goes into sleep mode after 10 minutes. The Presenter shuts down and the laser pointer automatically deactivates. Press any button to wake the device. Use the Laser Pointer hotkey to activate the laser pointer (see section 3). Third, the batteries may be running low. Try replacing the batteries.

Q4: How do Linstall this device on Windows 98SE?

A4: After you plug the USB receiver into an available USB port, follow the directions below:

- 1) When Windows detects the USB Human Interface Device, click Next.
- 2) Select Search for the best driver for your device (Recommended, then click Next.
- 3) Select only Specify a location, type in C:\WINDOWS and then click Next.
- 4) When Windows find the driver, click Next.
- 5) If prompted for it, put in your Windows 98SE CD, and then click OK.
 - 6) Click Finish.
 - 7) Windows will detect another USB Human Interface device. Repeat the steps above to complete the installation.


